Registration process for E-Tendering Portal

Enrolment process in the Tender site Bidders are required to enrol on the e-Procurement module of the Central Public Procurement 1 Portal (URL: https://etenders.gov.in/eprocure/app) by clicking on the link "Online Bidder Enrolment". Enrolment on the Portal is free of charge. As part of the enrolment process, the bidders will be required to choose a unique username and assign a 2 password for their accounts. Bidders are advised to register their valid email address and mobile numbers as part of the registration 3 process. These would be used for any communication from the Portal. Upon enrolment, the bidders will be required to register their valid Digital Signature Certificate (Class III Certificates with signing key usage) issued by any Certifying Authority recognized by CCA India, with their 4 profile.
