A. <u>Technical Evaluation Criteria</u>

- I. Bidder must have all necessary machining & fabrication facilities for manufacturing of cylinder valves for high pressure reciprocating pumps on their own. Bidder must submit documentary evidence detailing the machining and fabrication facilities at their work shop for machining of similar items such as cylinder valves for high pressure reciprocating pumps. For the same bidder must submit undertaking letter on their letter head detailing the above mentioned technical facilities of their workshop.
- II. Bidder shall provide the following documents along with technical bid
 - a. Party shall submit copy of minimum one PO for past supplies of same/similar items , successfully delivered in recent 7 year (from issuing date of this NIT) to any fertiliz er plant/Refineries/Petrochemical plant/Power plant/Continuous chemical process pl ant along with performance certificate from the end user clearly depicting that the supplied material performed satisfactory for 1 year after installation.
 - b. In case performance certificate is not available party shall submit their own certificate for above POs, mentioning that the performance of supplied material was satisfactory for 1 year after installation, along with contact detail of end user. In the case, performance claimed by party in their letter is not certified by end user, their offer shall liable to be rejected.

Definition of Similar items:

Supply of cylinder valves for high pressure reciprocating pumps of following criteria:

- 1. MOC of spares: A276-63T type 440B or higher grade material,
- 2. Material test certification, Hardness certificate and MPI testing certificates
- 3. The items must been supplied under Third Party Inspection.

The details & documents as per above (I) & (II) shall be provided along with technical bid for NFL r eview and technical evaluation of bid. Bids without these details are liable for technical rejection/di

squalification.

- **B.** Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sou ght in the Bid document, ATC and Corrigendum if any.
