Bidder shall be a manufacturer/ dealer/ Channel Partner of fasteners and have successfully supplied to fertilizers/ petrochemical/ refineries/ power plants/Oil & Gas plants/ continuous process chemical plant in last seven years ending 31.03.2024. Copy of successfully executed one Purchase Order for supply of fully threaded stud with two hex nuts and two washers of size M30 or above & MOC: A-193 Gr. B16/A-194Gr.2H or higher grade to be submitted along with your offer.

B. Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

C. Provisions of revised "Public Procurement" (Preference to make in India) order 2017 notified vide order no. P- 45021/2/2017-PP (BE-II) dated 16/09/2020 of Ministry of Commerce and Industry, Department of Industrial Policy and Promotion (DIPP) shall be applicable.

Bidders seeking benefits under Purchase Preference to Make in India (linked with local content) shall have to comply with the provisions specified under the revised Public Procurement (Preference to Make in India) order 2017. The salient features of which are as under:

(a) Minimum local content: - The minimum local content shall be applicable as per latest Government guidelines.

(b) Margin of Purchase Preference: - The margin of purchase preference shall be 20%.

The 'Class-I local supplier'/'Class-II Local supplier' at the time of tender, bidding or solicitation shall be required to indicate percentage of local content and provide self-certification that the item offered meets the local content requirement for 'Class-I Local supplier'/'Class-II Local supplier', as the case may be. They shall also give details of the locations (s) at which the local value addition is made.
