B. Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sou ght in the Bid document, ATC and Corrigendum if any.

C. Provisions of revised "Public Procurement" (Preference to make in India) order 2017 notified vi de order no. P- 45021/2/2017-PP (BE-II) dated 16/09/2020 of Ministry of Commerce and Industry, Department of Industrial Policy and Promotion (DIPP) shall be applicable.
