Bidder shall be manufacturer/Dealer/Channel partner of enquired items and have successfully sup plied to Fertilizers/Petrochemical/Refineries/Process plant/ Continuous process chemical plant/Pow er Plant in last seven years. Copy of successfully executed one Purchase Order to be submitted al ong with your offer.

- **B.** Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sou ght in the Bid document, ATC and Corrigendum if any.
- **C.** Provisions of revised "Public Procurement" (Preference to make in India) order 2017 notified vi de order no. P- 45021/2/2017-PP (BE-II) dated 16/09/2020 of Ministry of Commerce and Industry, Department of Industrial Policy and Promotion (DIPP) shall be applicable.
