Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service. If L-1 is not an MSE and MSE Seller (s) has/have quoted price within L-1+ 15% (Selected by Buyer) of margin of purchase preference /price band defined in relevant policy, such Seller shall be given opportunity to match L-1 price and contract will be awarded for 25%(selected by Buyer) percentage of total QUANTITY. All bidder should meet below requirement:

LED well glass light fitting of 35W having System Efficacy ≥ 120 lm/W, system output ≥ 8300 Lumens for 35W, THD $\leq 10\%$ (At Full load). Power Factor > 0.95 , CRI > 80

CCT 5700, Full IP 66 protected single piece die cast aluminium housing having PC with Impact resistance IK 08, Life L70350 @50k hrs. LED driver should be Potted & Encapsulated. BIS compliant driver should sustain 440V Stress Voltage protection for 8 Hrs. High Cut off: 325V(+/- 15V) and should have feature of Auto Restart, EMC -EMI compliant. Driver shall have 4KV Surge protection along with external 4KV Surge protection and feasibility. Fixture and driver have to be BIS certified as per the Govt. rule.
