Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference, the bidder must be the manufacturer of the offered product in case of bid for supply of goods. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service. If L-1 is not an MSE and MSE Seller (s) has/have quoted price within L-1+ 15% (Selected by Buyer)of margin of purchase preference /price band defined in relevant policy, such Seller shall be given opportunity to match L-1 price and contract will be awarded for 100%(selected by Buyer) percentage of total QUANTITY. The buyers are advised to refer the OM No.F.1/4/2021-PPD dated 18.05.2023 OM No.1 4 2021 PPD dated 18.05.2023 for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. 2. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

1. Scope of Supply

2. Buyer Added Bid Specific ATC

- 1. Kindly confirm that you shall submit Warranty certificate against any manufacturing defects/ w orkmanship & performance for a period of 24 months from the date of commissioning or 30 months from the date of supply, whichever is earlier along with supply of material
- 2. Kindly confirm that supplied material shall be as per attached specification
- $3.\ 90\ \%$ payment of PO value along with $100\ \%$ taxes towards supply portion shall be released with in $30\ days$ after reciept and acceptance of complete material at site in good condition . Balance $10\ \%$ of P O value for supply portion and $100\ \%$ payment of erection, testing and commissioning charges including taxes toward s installation/erection , commissioning and testing shall be released within $30\ days$ after succe ssful erection and commissioning. However if site not handed over for erection and commissioning within 6 months from date of PO, balance $10\ \%$ of supply part shall be paid to the party against submission of unconditional bank guarantee of equivalent amount from the bidder
- 4. Deviations, if any, quoted by bidder should be attached in separate sheet
- 5. Bidder shall supply all material within 120 days from the date of award of GEM contract
- 6. Erection, Testing & Commissioning job will be carried out during well-defined time. The same wil I be intimated to party 7 to 10 days in advance through Phone/E-mail or letter by Speed post. Erection, tes ting at site, installation & commissioning shall be completed in all respect within 20 days from the date of site handover and total job completion including Supply, Erection, testing at site, installation & commission ing shall be completed in all respect within 180 days from the date of award of contract. The rates of Erection, Testing & commissioning shall be valid for one year from the date of placement of contract. Bidder shall confirm the same in their offer
- 7. LD shall be applicable on material and Erection and commissioning part as per GTC of GeM
- 8. Kindly confirm that you will submit duly signed and stamped copy of acceptance of all additional t erms and condition (ATC) and document uploaded in buyer specific ATC document on your letter head
- 9. Supplier/ vendor whose turnover exceeds Rs. 5.00 Crore in any financial year from 2017-18, is r equired to issue E-Invoice as per the provision of Rule 48 of CGST Act, 2017. If the supplier/ vendo r fails to comply with the provision of Rule 48, such invoice will not be a valid invoice and the recip ient/ buyer will not be entitled to claim the Input Tax Credit of GST paid as per section 16(2)(a). Yo u may kindly specify whether E-invoice provisions are applicable to you.

- 2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
- 3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
- 4. Creating BoQ bid for single item.
- 5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
- 6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
- 7. Floating / creation of work contracts as Custom Bids in Services.
- 8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for <u>attached categories</u>, trials are allowed as per approved procurement policy of the buyer nodal Ministries)
- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.

- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
