1. Preference to Make In India products (For bids < 200 Crore):Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. - (i.) Bidder must have successfully completed manufacturing, testing and supply of "Similar Item". Bidder must have all facilities for necessary manufacturing, Testing and supply of triplex plunger pumps on their own. Bidder must submit documentary evidence detailing t

he necessary manufacturing facilities at their workshop for necessary manufacturing of triplex plunger pumps. For the same bidder must submit undertaking letter on their letter head detailing the above mentioned technical facilities of their workshop.

- (ii.) Bidder shall provide the following documents along with technical bid
- a) Details of past supplies of similar items of tender, successfully delivered in recent past 7 year (ending on last date of previous month of date of issue of NIT i.e. 30.04.2024) to Fertilizers, Petro chemical, process industries or thermal power plants; preferably P SUs.

**Definition of Similar Item:**

Similar Item means supply of triplex plunger pump meeting the following minimum technical criteria:

1. Minimum designed flow of 1m<sup>3</sup>/hr or more & minimum head required is 8 mtr or more.
  2. Pumping media is Water.
  3. Material test certificate, performance curve of the pump, hydraulic test certificates .
  4. Item must be supplied under Third Party Inspection.
- b) Party to submit details of **One numbers of Purchase Order(s)/ work order(s) copies** in line with serial number # ii/a/1,2,3 and 4 above; mentioning the PO/WO Number, Date, Client Name, Address, Contact Number, Contact Email, Reference Contact Person, item details (in line or similar to the items mentioned in the tender) and copies of Job Completion Certificates or any other support documents such as Delivery Receipts / Client Acknowledgements / Payment Receipts / Client Endorsement by mail or letters , etc. to support/prove the successful supply of similar items as well as satisfactory performance of items/materials supplied. In case performance feedback or PTR is not available owing to installation & commissioning delays at referred client's end, TPI IRN (Inspection Release Note) or Client Dispatch Clearance Note/Communication details to be submitted.

The details & documents as per above (i) & (ii) shall be provided along with technical bid for NFL review & technical evaluation of bid. Bids without these details are liable for technical rejection / disqualification.

**B.** Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

**C.** Provisions of revised "Public Procurement" (Preference to make in India) order 2017 notified vide order no. P- 45021/2/2017-PP (BE-II) dated 16/09/2020 of Ministry of Commerce and Industry, Department of Industrial Policy and Promotion (DIPP) shall be applicable.

Bidders seeking benefits under Purchase Preference to Make in India (linked with local content) shall have to comply with the provisions specified under the revised Public Procurement (Preference to Make in India) order 2017. The salient features of which are as under:

- (a) Minimum local content: - The minimum local content shall be applicable as per latest Government guidelines.
- (b) Margin of Purchase Preference: - The margin of purchase preference shall be 20%.
