If L-1 is not an MSE and MSE Seller (s) has/have quoted price within L-1+ 15% (Selected by Buyer) of margin of purchase preference /price band defined in relevant policy, such Seller shall be given opportunity to match L-1 price and contract will be awarded for 25%(selected by Buyer) percentage of total QUANTITY. 1. You shall submit Warranty certificate against any manufacturing defect, which shall be valid for a period of 18 months from the date of supply or 12 months from the date of installation whichever is earlier along with supply of material

2. Only OEM M/s Joseph Leslie/ 3M/ Du Pont/ Respirex /Ansell Microguard or their authorized dealer can only participate in this bid. Bidder has to submit valid authorization certificate for the same along with the offer

3. Kindly confirm that you shall provide all required certificates related to warranty , testing and markings as mentioned in the specifications

4. Kindly confirm that size of suit shall be in combination of the XL and L option which shall be finalized in consultation with the L1 party prior to dispatch of the item

5. Payment term shall as follows:

100 % payment shall be released within 30 days after receipt and acceptance of material at NFL Stores, Panipat. Vendor should provide their latest bank details (valid bank mandate/ cancelled cheque copy/on their letterhead, etc.) at the time of invoice submission

6. Supplier/ vendor whose turnover exceeds Rs. 5.00 Crore in any financial year from 2017-18, is required to issue E-Invoice as per the provision of Rule 48 of CGST Act, 2017.
