- 1. Preference to Make In India products (For bids < 200 Crore):Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. - Bidder shall be a manufacturer or dealer/channel partner/ network agent authorized by the manufacturer of **Vibrating Screen**. In case of dealer or channel partner or network agent, authorization letter or MoU or Agreement made with manufacturer shall be sub mitted along with technical bid.
- II. Bidder shall provide the following documents along with technical bid
- a) Party shall submit copy of minimum one PO for past supplies of same/similar items, successfully delivered in recent 7 year (ending issuing date of this NIT i.e. 14.05.2024) to any fertilizer plant/R efineries/Petrochemical plant/Power plant/Continuous chemical process plant along with performa nce certificate from the end user clearly depicting that the supplied material performed satisfactor y for 1 year after installation.

b) In case performance certificate is not available party shall submit their own certificate for above POs, mentioning that the performance of supplied material was satisfactory for 1 year after install ation, along with contact detail of end user.

Definition of Similar items:

Supply of Vibrating Screen of minimum inlet feed material at 2.25TPH capacity.

- **B.** Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sou ght in the Bid document, ATC and Corrigendum if any.
- **C.** Provisions of revised "Public Procurement" (Preference to make in India) order 2017 notified vi de order no. P- 45021/2/2017-PP (BE-II) dated 16/09/2020 of Ministry of Commerce and Industry, Department of Industrial Policy and Promotion (DIPP) shall be applicable.
