- 3. Delivery Days mentioned as 365 Days on GeM Bid/Contract is actually Period of contract & not delivery period for D elivery orders
- 4. Offer Prices on GeM shall be on all inclusive basis i.e. including all taxes, duties, local levies / transportation etc.
- 5. Bidder has to quote Total Price for All Volatile Treatment Package on GeM portal as calculated at SI. No. 4 of Table fo r Schedule of Rates (SOR) in annexure-II of Technical Section. No other cost shall be admissible other than stated on GeM Portal.
