- b) Guarantee certificate against any manufacturing defects which shall be valid for a period of 18 months f rom the date of supply or 12 months from the date of installation whichever is earlier along with supply of material and same shall be confirmed by you along with your offer
- c) Hydraulic test certificate of pipe fittings like CS Elbow, CS Equal Tee, CS Unequal tee
- 2. Deviation, if any, quoted by bidder should be attach in separate sheet
