If the bidder wants to avail the Purchase preference, the bidder must be the manufacturer of the offered product in case of bid for supply of goods. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service. If L-1 is not an MSE and MSE Seller (s) has/have quoted price within L-1+ 15% (Selected by Buyer) of margin of purchase preference /price band defined in relevant policy, such Seller shall be given opportunity to match L-1 price and contract will be awarded for 100%(selected by Buyer) percentage of total QUANTITY. Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

**2. Buyer Added Bid Specific ATC**

Buyer Added text based ATC clauses

1. Scope of Supply: as per tender document.
2. Payment Terms: 100% payment within 30 days of receipt & acceptance of the material.
3. Bidder shall be either OEM or its authorised channel partner/distributor. In case of authorized channel partner/ distributor, bidder shall submit authorization letter from OEM.
4. Bidder must have supplied atleast one similar (high pressure letdown with differential pressure design of equal to or more than 82Kg/cm<sup>2</sup> in quench water or steam service) control valve in last 7 years. In this regard, bidder shall submit PO copy as proof of supply.
5. Bidder shall submit performance certificate from Client for 6 month continuous satisfactory service of supplied valve.
6. Party to confirm that no change in existing pipeline will be done. Retrofitting with existing control valve in all respects shall be bidder responsibility.
7. Party shall submit Guarantee/ Warranty certificate against poor workmanship, defects etc. for a period of 12 months from date of installation/commissioning or 18 months from date of supply whichever is earlier.
8. Party to submit material test certificate for body and trim parts, hydro test certificate, IBR (Form IIIC), PMI and radiography certificate for body and bonnet of supplied control valve.
9. Party to submit complete dimensional drawing of new valve along with offer.
10. After placement of contract, successful bidder shall submit quality control plan to NFL within 15 days from the date of issue of contract. After approval of QCP from NFL

, vendor shall start manufacturing.

6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
7. Floating / creation of work contracts as Custom Bids in Services.
8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for [attached categories](#), trials are allowed as per approved procurement policy of the buyer nodal Ministries)
9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
