Preference to Make In India products (For bids < 200 Crore):Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. - 1. Successful bidder to provide mounting arrangement for 2003 solenoid valve assembly so that retrofittin g on existing 1002 solenoid valve can be done. Party may visit NFL Panipat site for assessment of existing installation. This visit shall be free of cost i.e. no charges shall be borne by NFL for this visit.
- 2. Party to confirm that offered material have online diagnostic and maintenance facility i.e. There shall be visual indication for detection of individual coil failure and a provision of online replacement of faulty coil w ithout equipment shut down.
