- 1) Payment Terms: 100% of Purchase Order value towards supply and service (Successful Installation, Commissioning Demonstration) portion plus 100% taxes towards supply and service portion within 30 days after Receipt & Acceptance of Material at our site through RTGS. As per Clause no. 12 (Payment Authority and Payment Terms), sub clause (i) (FOR GOODS) under General terms and Conditions of GeM which is as follows: "In case of goods, 100% payment will be released within ten (10) days of issue of consignee receipt-cum-acceptance certificate (CRAC) and on-line submission of bills unless otherwise specified in STC / ATC." Please note that no deviation in the payment terms shall be acceptable in the current case and in case of any deviation, your offer shall be liable to be rejected outrightly.
- 2) <u>Liquidated Damages / Penalty for Late Delivery:</u> It shall be obligatory on the part of Suppliers to adhere strictly to the deliveries quoted and accepted by us in our Purchase Order/Contract/Delivery Order whichever is applicable.
