- 1. Preference to Make In India products (For bids < 200 Crore):Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. Bidder shall be manufacturer/Dealer/Channel partner of indented items and have successfully sup plied the enquired machines to Fertilizers/ Petrochemical/ Refineries /Process plant/Continuous pro cess chemical plant in last seven years ending issue date of bid document i.e. 30.05.2024. Copy of successfully executed one PO, should be submitted along with your offer.

- **B.** Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sou ght in the Bid document, ATC and Corrigendum if any.
- **C.** Provisions of revised "Public Procurement" (Preference to make in India) order 2017 notified vi de order no. P- 45021/2/2017-PP (BE-II) dated 16/09/2020 of Ministry of Commerce and Industry, Department of Industrial Policy and Promotion (DIPP) shall be applicable.

Bidders seeking benefits under Purchase Preference to Make in India (linked with local content) sh all have to comply with the provisions specified under the revised Public Procurement (Preference to Make in India) order 2017. The salient features of which are as under:

(a) Minimum local content: - The minimum local content shall be applicable as per latest Gov ernment guidelines.
