3. The qty mentioned at para 2 above shall be dispatched in approx. 700 consignments. The Fix Door Delivery/Handling/Misc. Charges of Rs. 1,500/- Per Consignment/invoice (**GST Extra**) shall be given in addition to per kg rate quoted by transporter for each state. In case order is splitted among multiple parties, 700 consignments shall be splitted proportionately.
4. The material will be dispatched to various destinations across the state as mentioned at para 2 above on need basis in small consignments. The qty and list of destinations will be provided by NFL officer in-charge to transporter at least 2 days in advance to place the vehicle at NFL Vijaipur for loading. NFL does not guarantee minimum quantity for each destination (Minimum qty can also be a 01 box for destination) and transporter is bound to pick up the material. 6. In case of non-placement of vehicle by transporter at stipulated date, NFL reserves the right, at his sole discretion to nominate other transporter for dispatch of bio fertilizer. The difference in freight amount shall be recovered from original transporter.
7. The loading of consignments at NFL Vijaipur shall be responsibility of NFL. However, the unloading of consignment at destination is the responsibility of transporter and no unloading charge / labour assistance shall be demanded from the consignee or his representative. Further, the transporter shall be responsible for obtaining acknowledgement of material on GR copy from the consignee.
8. The material in transit will be insured by NFL. However, the transporter shall be responsible for the safety of the items from the time they are loaded on their truck until they have been unloaded from the trucks at godowns or at other destinations as specified in the invoice. The transporter shall take reasonable precautions to avoid wetting/damage/loss to cartons during the transport. In respect of any shortage, wastage, loss or damages to the goods in transit, the transporter is liable to pay the Liquidated Damages/recovery from bill as decided by the NFL.
9. The timely delivery of the consignment is essence of this contract. The material shall be delivered to the destination maximum within 20 days from the date of dispatch of vehicle from NFL Vijaipur. It shall be obligatory on the part of transporter to adhere strictly to the delivery schedule quoted and accepted by us in our orders. The LD shall be applicable @ 100/day for each delayed consignment,

subject to maximum of 10 % of freight value for the delayed consignment. GST as applicable on the LD Charges / Penalty shall also be recoverable in addition to LD Charges/Penalty applicable on delayed delivery.

10. The Contractor shall not sublet, transfer, or assign the Contract, or any part thereof.
11. The Contract shall remain in force for a period of ONE YEAR from the date of issue of LOI/Work Order. All rates will be treated as firm for the period of the contract. No escalation whatsoever shall either be claimed or be considered by NFL. NFL reserves the right to extend the validity of work order for further period of three months at the same rate & terms and conditions to dispatch balance quantity of work order, if any, at its sole option.
12. The NFL have the exclusive right to appoint one or more transporter for any or all the states and to divide the work between such transporter in any manner that the NFL may decide and no claim shall lie against the NFL by reason of such division of work.
13. No compensation shall be admissible to the Contractor in respect of detention of trucks at the loading/unloading points or any other place unless such detention is of an extraordinary kind. The decision of the NFL Officer in-Charge in all such matters shall be final.
14. No additional expenditure on any account shall be paid to the transporter other than the approved rates.
