- 1) Payment Terms: 100% of Purchase Order value towards supply and service (Successful Installation, Commissioning Demonstration) portion plus 100% taxes towards supply and service portion within 30 days after Receipt & Acceptance of Material at our site through RTGS. As per Clause no. 12 (Payment Authority and Payment Terms), sub clause (i) (FOR GOODS) under General terms and Conditions of GeM which is as follows: "In case of goods, 100% payment will be released within ten (150) days of issue of consignee receipt-cum-acceptance certificate (CRAC) and on-line submission of bills unless otherwise specified in STC / ATC.
