### Additional Terms & Conditions (ATC)

- VI. Guarantee/Warranty: The offered material shall be guaranteed against any manufacturing defect and poor workmanship for a period of 18 months from the date of supply or 12 months from the date of commissioning, whichever is earlier. In case the material fails during guarantee period due to defective material or bad workmanship, you will have to replace/rectify the same free of cost. The guarantee certificate should indicate our order number and your invoice number. Guarantee/Warranty Certificate shall be submitted along with dispatch documents.
